

OFFICIAL CONTEST RULES & REGULATIONS FOR "TU PENSAMIENTO ROMANTICO"

NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING.
VOID WHERE PROHIBITED.

1. These rules govern the "TU PENSAMIENTO ROMANTICO" (the "Contest") being conducted by WRMA-FM (the "Station") beginning on Thursday, July 18th, 2011 through Thursday, August 04th, 2011 between the hours of 6:00AM and 8:00PM
2. ELIGIBILITY
 - A. Contestants must (i) be at least 18 years of age to participate, (ii) have a valid Florida Driver's License, and (iii) have a valid social security number and card, or a valid taxpayer identification number ("TIN").
 - B. Employees of the Station, Spanish Broadcasting System, Inc., its affiliates, subsidiaries and their public relations agencies, participating sponsors and "family" members ("family" is defined as spouse, parents, children, sibling, aunts, uncles, cousins and grandparents) are ineligible.
 - C. One prize per winner from each immediate "family" ("family" is defined as spouse, parents, children, sibling, aunts, uncles, cousins and grandparents) and/or "household" ("household" is defined as anyone living at the same address) is allowed during the term of this Contest.
 - D. Any individual who wins \$600 (six hundred dollars) or more must provide the Stations with valid identification and a valid TIN or social security card and number, and a valid government-issued photo identification which contains the individual's current address before any prize will be awarded. Failure to present a valid social security card or TIN may result in a disqualification of the winner, in which case the prize shall be forfeited.
 - E. **If a winner selected is later determined by the Station to be ineligible, no prize will be awarded to the ineligible contestant and the Station reserve the right to award the prize to a qualified contestant.**
3. NATURE OF CONTEST:

Beginning Thursday July 25th, 2011 through Thursday, August 04th, 2011 between the hours of 6:00AM and 8:00PM promotional spots will ask WRMA-FM listeners to log-in to the Station's website at www.romancefm.com to register for the opportunity to win, \$1,000.00 Courtesy of Del Angel Music. Once registered, which includes writing their pensamiento romantico, the listener must listen for their name to be announced live on air by DJ, between the hours of 7:00AM and 8:00PM EST during the contest period. Once the qualified listener name is mentioned, that qualified listener will have exactly ten (10) minutes to call-in to the Station's listener lines at (305) 550-9106. If the qualified listener calls in within the ten (10) minutes allotted and identifies herself or himself correctly, that lucky qualifier will be announced live on-air by one of the radio station DJs and will be one of the final qualifiers for the grand prize Courtesy of Del Angel Music (see below). If qualified listener does not call in to the Station's listener lines at (305) 550-9106 within the allotted time of ten (10) minutes, the qualified listener will not become a qualified finalist and no qualified finalist will be determined in that hour.

On Thursday July 28th, 2011 & August 04th, 2011 the DJ of the Station will randomly select from all qualified finalists one of their pensamiento romantico. The final qualified finalists must listen for their name to be announced live on air by DJ, between the hours of between the hours of 12:00PM and 1:00PM, that qualified finalists will have exactly ten (10) minutes to call-in to the Station's listener lines at (305) 550-9106. If the qualified finalist calls in within the ten (10) minutes allotted and identifies herself, or himself correctly, that lucky finalist will be announced live on-air by one of the radio station DJs and will win one of the two grand prizes (see below). If qualified finalist does not call in to the Station's listener lines at (305) 550-9106 within the allotted time of ten (10) minutes, the prize will be forfeited and no prize will be awarded that week.

There will be a total of up to Three Hundred-eighteen (318) listeners qualified on WRMA-FM from Thursday July 25th, 2011 & August 04th, 2011 (Restrictions apply).
4. CONDITIONS FOR PARTICIPATION

The Station is not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including: failed, traffic congestion on telephone lines.

No mechanical duplication of entries will be allowed. The Station is not responsible for any connection problems or phone problems on the entry side. All entries become the exclusive property of the Station. By entering this Contest, participants agree to be bound by these Official Rules and the decisions of the Station whose decisions shall be final, binding and conclusive on all matters relating to this Contest.

The Station reserves the right to disqualify any participant or winner and may refuse to award any prize to a person who is ineligible or who the Station believes has violated any rule, gained unfair advantage in participating in the Contest, or obtained winner status using fraudulent means. The Station will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest and the Station's decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Station, the Station reserves the right to terminate this Contest, or make such other decisions regarding the outcome as the Station deems appropriate. All decisions will be made by the Station and are final.

5. PRIZE:

- Two (2) winners will win cash prizes of \$1,000.00 Courtesy of Del Angel Music. The total combined value of all prizes awarded to winners is \$2,000.00 Courtesy of Del Angel Music.
- No substitutions permitted except at the sole discretion of the Station, in which case a prize of greater or equal value will be awarded. The Station makes no warranty with respect to any Contest prize and is not responsible for cancellation or postponement. The cash equivalent of any portion of any Contest prize is not permitted, except at the Station's sole discretion. The Station will report value of prizes as required by law.

6. RETAIL VALUE:

- The Approximate Retail Value for each prize awarded, \$1,000 cash Courtesy of Del Angel Music
- The Total Approximate Retail Value ("ARV") for all possible prizes awarded will depend on the total amount of qualified listeners that are able to call into the stations listener lines (see nature of contest section above).

7. ODDS OF WINNING.

The odds of winning depend on the number of eligible participants.

8. RELEASE:

By participating in the Contest, each participant waives any and all claims of liability against the Stations, Spanish Broadcasting System, Inc., its subsidiaries, affiliates and participating sponsors and their respective employees, directors, shareholders and agents, from any and all claims, liabilities and damages arising directly or indirectly out of the award of the prize or that may be sustained directly or indirectly in connection with this Contest, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize or for any claims, liabilities, losses, repairs, damage or injuries arising out of or in conjunction with the services, merchandise or other benefits obtained by the winner or this Contest. In order to receive a prize, participants must sign an official waiver form provided by the Stations.

9. REDEEMING OF PRIZE: All prizes must be redeemed or claimed by 10 days after date the winner is announced, at 7007 NW 77th Ave., Medley, Florida 33166 Monday through Friday between the hours of 9:00 AM to 5:00 PM.

10. PUBLICITY, USE OF PERSONAL INFORMATION:

By participating, all participants and winners grant the Stations the non-exclusive permission to use their names, characters, photographs, voices, biographical information and likenesses in connection with promotion of the Contest and waive any claims to royalty, right, or remuneration for such use. By participating in the Contest, participants agree that the Stations may disclose personal information obtained from participants in the Contest to third parties and use such information for marketing and other purposes.

11. Any tax or additional expenses incurred as a result of the prize are the sole responsibility of each winner. The value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes related to the prize(s) and paying any expenses associated with any prize that is not specifically provided for in these official rules. Any person winning over \$600 in prizes from the Stations will receive an IRS form 1099 at the end of the calendar year and a copy of such form will be filed with the IRS.
12. Prizes may not be substituted, are not transferable, redeemable for cash or exchangeable for any other prize. Prizes may not be claimed or used by any person other than the winner.
13. The Station reserves the right to award additional prizes throughout the Contest.
14. Any rule changes after the Contest begins must not disadvantage Contest participants and will be announced promptly and conspicuously.
15. The Station disclaims all liability for any delays, misdelivery, loss, or failure in the delivery of any item sent by mail, courier, express, or other delivery method. The Station is not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including: failed, traffic congestion on telephone lines.
16. Each winner must submit proof of eligibility and sign the Stations' release form to claim the prize. Void where prohibited. In the event the Stations are prevented from continuing with the Contest or the integrity and/or feasibility of the Contest is severely undermined by an event beyond the Stations' control, the Stations may substitute prizes of equal or greater value or discontinue the Contest at any time. In no event will the Stations be obligated to award more than the number of prizes stated in these Official Rules. The Stations disclaim any responsibility to notify participants of any aspect related to the conduct of the Contest.
17. The conduct of the Contest is governed by the applicable laws of the U.S., which take precedence over any rule to the contrary herein. The Stations shall follow the applicable laws for posting of a prize bond, furnishing lists of winners, running specific on-air disclaimers, providing specific written information about the contest, etc. as required by local, state and law.
