

**OFFICIAL CONTEST RULES & REGULATIONS FOR  
“TRIP TO PUERTO RICO & SHAKIRA CONCERT” (the “Contest”)**

NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING.  
VOID WHERE PROHIBITED.

1. These rules govern the “TRIP TO PUERTO RICO & SHAKIRA CONCERT” (the “Contest”) being conducted by WRMA-FM (the “Stations”) beginning on Monday August 29<sup>th</sup>, 2011 through Monday October 03<sup>rd</sup>, 2011 between the hours of 6:00AM and 11:00PM

2. ELIGIBILITY

- A. Contestants must (i) be at least 18 years of age to participate, (ii) have a valid Florida Driver's License, and (iii) have a valid social security number and card, or a valid taxpayer identification number (“TIN”).
- B. Employees of the Station, Spanish Broadcasting System, Inc., its affiliates, subsidiaries and their public relations agencies, participating sponsors and “family” members (“family” is defined as spouse, parents, children, sibling, aunts, uncles, cousins and grandparents) are ineligible.
- C. One prize per winner from each immediate “family” (“family” is defined as spouse, parents, children, sibling, aunts, uncles, cousins and grandparents) and/or “household” (“household” is defined as anyone living at the same address) from WRMA-FM, WXDJ-FM, WCMQ-FM, and WRAZ-FM combined is allowed within a thirty (30) day period..
- D. Any individual who wins \$600 (six hundred dollars) or more from WRMA-FM, WXDJ-FM, WCMQ-FM, and WRAZ-FM combined must provide the Stations with valid identification and a valid TIN or social security card and number, and a valid government-issued photo identification which contains the individual's current address before any prize will be awarded. Failure to present a valid social security card or TIN may result in a disqualification of the winner, in which case the prize shall be forfeited.
- E. **If a winner selected is later determined by the Station to be ineligible, no prize will be awarded to the ineligible contestant and the Station reserve the right to award the prize to a qualified contestant.**

3. NATURE OF CONTEST:

Beginning Monday August 29<sup>th</sup>, 2011 through Monday October 03<sup>rd</sup>, 2011 between the hours of 6:00AM and 12:00AM, Monday-Sunday, listeners will have the opportunity to register for the grand prize (see below) two (2) different ways.

- A. **ON AIR QUALIFING:** Listen to WRMA-FM 106.7FM, upon hearing the DJ's cue to call, listeners will have the opportunity to call-in to the Station's contest line at (305) 883-5531 between the hours of 6am through 11pm The first ten callers will be registered for a random drawing for the chance to win the Grand Prize which consists of a trip for two (2) to Puerto Rico to attend the Shakira Concert at the Coliseo de Puerto Rico Jose Miguel Agrelot, in San Juan on Saturday October 15<sup>th</sup>, 2011 at 8:30PM (see below).
- B. **WEBSITE REGISTRATION:** Going to the stations website at [www.romancefm.com](http://www.romancefm.com) and using the Shakira Flyaway to Puerto Rico registration page. Of all qualified registries received will be qualified to participate in the grand prize drawing. Each qualifier will be required to provide his or her first and last name, complete address, telephone number and date of birth when he or she qualifies. The Station is not responsible for internet outages, delays, or equipment malfunctions and any other technological difficulties that may prevent an individual from completing his or her registration.

On the following Mondays 9/05/11, 9/12/11, 9/19/11, 9/26/11, & 10/03/11, during the “Morning Show at 7:25AM, One (1) Grand Prize Winner will be randomly chosen (as solely determined by the Station) from all eligible entered and registered entries. Each Grand Prize Winner will be announced live on-air via phone, by one of the radio station DJs. Each Grand Prize Winner will receive A Trip for two (2) to Shakira's Concert at

the Coliseo de Puerto Rico Jose Miguel Agrelot, in San Juan on Saturday October 15<sup>th</sup>, 2011 at 8:30PM. Trip includes: round-trip coach air transportation for two (2) people from a Miami Area Airport to a Airport in San Juan, PR; a two (2) nights hotel accommodations (standard room, double occupancy) at San Juan Beach Resort; and two (2) tickets to Shakira's Concert at the Coliseo de Puerto Rico Jose Miguel Agrelot, in San Juan on Saturday October 15<sup>th</sup>, 2011 at 8:30PM ARV: \$2,500.00.

There will be a total of five (5) Grand prize winners selected on WRMA-FM from, Monday August 29<sup>th</sup>, 2011 through Monday October 03<sup>rd</sup>, 2011 (Restrictions apply).

#### 4. CONDITIONS FOR PARTICIPATION

The Station is not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including: failed, traffic congestion on telephone lines.

No mechanical duplication of entries will be allowed. The Station is not responsible for any connection problems or phone problems on the entry side. All entries become the exclusive property of the Station. By entering this Contest, participants agree to be bound by these Official Rules and the decisions of the Station whose decisions shall be final, binding and conclusive on all matters relating to this Contest.

The Station reserves the right to disqualify any participant or winner and may refuse to award any prize to a person who is ineligible or who the Station believes has violated any rule, gained unfair advantage in participating in the Contest, or obtained winner status using fraudulent means. The Station will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest and the Station's decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Station, the Station reserves the right to terminate this Contest, or make such other decisions regarding the outcome as the Station deems appropriate. All decisions will be made by the Station and are final.

#### 5. PRIZE:

- (1) Grand Prize – A Trip for two (2) to Shakira's Concert at the Coliseo de Puerto Rico Jose Miguel Agrelot, in San Juan on Saturday October 15<sup>th</sup>, 2011 at 8:30PM. Trip includes: round-trip coach air transportation for two (2) people from a Miami Area Airport to a Airport in San Juan, PR; a two (2) nights hotel accommodations (standard room, double occupancy) at San Juan Beach Resort; and two (2) tickets to Shakira's Concert at the Coliseo de Puerto Rico Jose Miguel Agrelot, in San Juan on Saturday October 15<sup>th</sup>, 2011 at 8:30PM ARV: \$2,500.00. The actual retail value of the trip will depend on winner's time of departure/return; no cash equivalent will be awarded. Winners must depart on 10/14/2011 and return on 10/16/2011. Winner and guest must travel together on the same itinerary. All travel arrangements and accommodations at the discretion of the Sponsor and are subject to change. All travel-related expenses not set forth herein, including meals, gratuities and incidental hotel expenses are the sole responsibility of Grand Prize winners. Seat location at Sponsor's sole discretion. If Shakira's Concert is delayed, postponed or cancelled for any reason, winner will not receive tickets as part of prize or any monetary compensation, but tickets may be subject to standard rain-check policies and procedures established by issuer. Prize consists of only the items specifically listed as part of the prize.
- Contest prizes does not include any alcoholic beverages, hotel room service, merchandise, souvenirs, etc., local and long distance telephone calls, gratuities and any and all other expenses not otherwise described herein.
- No substitutions permitted except at the sole discretion of the Station, in which case a prize of greater or equal value will be awarded. The Station makes no warranty with respect to any Contest prize and is not responsible for cancellation or postponement. The cash equivalent of any portion of any Contest prize is not permitted, except at the Station's sole discretion. The Station will report value of prizes as required by law.
- Winner and guest, as applicable, must have all required documentation prior to departure and are responsible for obtaining all travel documents. Credit Card may be required to cover incidentals and costs.

6. RETAIL VALUE: GRAND PRIZE: Total Approximate Retail Value ("ARV") for the entire promotion is \$2,500.00.

7. ODDS OF WINNING.

The odds of winning depend on the number of eligible participants.

8. RELEASE:

By participating in the Contest, each participant waives any and all claims of liability against the Stations, Spanish Broadcasting System, Inc., its subsidiaries, affiliates and participating sponsors and their respective employees, directors, shareholders and agents, from any and all claims, liabilities and damages arising directly or indirectly out of the award of the prize or that may be sustained directly or indirectly in connection with this Contest, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize or for any claims, liabilities, losses, repairs, damage or injuries arising out of or in conjunction with the services, merchandise or other benefits obtained by the winner or this Contest. In order to receive a prize, participants must sign an official waiver form provided by the Stations.

9. REDEEMING OF PRIZE: All prizes, including cash prizes won by qualifiers during the Contest period will be available immediately on the day of the qualified call.

10. PUBLICITY, USE OF PERSONAL INFORMATION:

By participating, all participants and winners grant the Stations the non-exclusive permission to use their names, characters, photographs, voices, biographical information and likenesses in connection with promotion of the Contest and waive any claims to royalty, right, or remuneration for such use. By participating in the Contest, participants agree that the Stations may disclose personal information obtained from participants in the Contest to third parties and use such information for marketing and other purposes.

11. Any tax or additional expenses incurred as a result of the prize are the sole responsibility of each winner. The value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes related to the prize(s) and paying any expenses associated with any prize that is not specifically provided for in these official rules. Any person winning over \$600 in prizes from the Stations will receive an IRS form 1099 at the end of the calendar year and a copy of such form will be filed with the IRS.

12. Prizes may not be substituted, are not transferable, redeemable for cash or exchangeable for any other prize. Prizes may not be claimed or used by any person other than the winner.

13. The Station reserves the right to award additional prizes throughout the Contest.

14. Any rule changes after the Contest begins must not disadvantage Contest participants and will be announced promptly and conspicuously.

15. The Station disclaims all liability for any delays, misdelivery, loss, or failure in the delivery of any item sent by mail, courier, express or other delivery method. The Station is not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including: failed, traffic congestion on telephone lines.

16. Each winner must submit proof of eligibility and sign the Stations' release form to claim the prize. Void where prohibited. In the event the Stations are prevented from continuing with the Contest or the integrity and/or feasibility of the Contest is severely undermined by an event beyond the Stations' control, the Stations may substitute prizes of equal or greater value or discontinue the Contest at any time. In no event will the Stations be obligated to award more than the number of prizes stated in these Official Rules. The Stations disclaim any responsibility to notify participants of any aspect related to the conduct of the Contest.

17. The conduct of the Contest is governed by the applicable laws of the U.S., which take precedence over any rule to the contrary herein. The Stations shall follow the applicable laws for posting of a prize bond, furnishing lists of winners, running specific on-air disclaimers, providing specific written information about the contest, etc. as required by local, state and law.
